How much subsidy does India Government give on solar panels?

Out of all the states that offer a govt subsidy on solar panels, only Gujarat has been able to overcome the hurdles and popularize the adoption of solar



among homeowners. Over 3 Lakh homes have already purchased solar and taken the benefit of the subsidy.

How much subsidy does a solar system get?

Here are the true subsidy calculation parameters: For a solar system between 1 KW to 3 KW, you get a 40% subsidy on the L1 price. For a solar system that is more than 3 KW and up to 10 KW, you get a 20% subsidy on the L1 price. You can discuss matters with your solar installation company.
