# Foreign-funded battery pack factory







#### **Overview**

Are Chinese battery makers building overseas factories?

[Photo/VCG] In response to growing demand and stricter policy restrictions, Chinese battery makers are ramping up efforts to construct overseas factories.

Where will EV batteries be made?

Just five days earlier, Anhui-based Gotion unveiled plans to set up a \$2 billion EV lithium battery manufacturing plant in Illinois, the United States. Located in the city of Manteno, the facility is expected to produce 10 gigawatt-hours of lithium-ion battery packs and 40 GWh of lithium-ion battery cells a year when it begins production next year.

Are EU-wide & national requirements based on foreign battery investment?

Analysis of foreign battery investments in EU External experts commissioned by T&E find no EU-wide or national requirements on technology transfer and breaches of air pollution rules from battery factories in Poland and Hungary. T&E calls on clear foreign investment rules and a comprehensive European strategy for battery supply chains.

Which companies are launching a new battery production plant in China?

In May, refrigeration industry giant Danfoss inaugurated its global refrigeration research and development (R&D) and testing center in Tianjin. In the same month, BMW Group's joint venture in China, BMW Brilliance Automotive Ltd., began the construction of a new battery production plant in Liaoning's capital Shenyang.

Will China be the largest battery factory in Europe in 2025?

It will be the largest battery factory in Europe when production begins in 2025.



According to data from the Ministry of Industry and Information Technology, in the first half of this year, China's lithium battery product exports increased by 69 percent year-on-year, with a predominant focus on power batteries.

Can Europe build a world-leading battery industry?

T&E calls on clear foreign investment rules and a comprehensive European strategy for battery supply chains. Europe's ambition to build a world-leading battery industry is facing many headwinds. As local plans falter, over 90% electric car and storage batteries are produced by South Korean and Chinese companies in the EU.


